GENERAL INFORMATION

Please note that:

1. The 2013 FIM Sidecar Motocross World Championship entry form has been published on the FIM Website from where it must be downloaded:

204 - FIM Sidecar Motocross World Championship - 2013 Entry Form

2. The 2013 FIM Sidecar Motocross World Championship entry form must be completed electronically in capital letters

As a general rule, every driver/passenger wishing to participate in the 2013 FIM Sidecar Motocross World Championship must enter through their FMN and the FMNR/Organiser respectively.

The driver and passenger must complete the entry form for each 2013 FIM Sidecar Motocross World Championship meeting they wish to enter.

Entry requests/provisional entries can be made by e-mail or telefax to the FMNR/Organiser, but they must be confirmed with the duly completed official FIM entry form.

To be eligible for participation in FIM World Championships or Prize Events and in order to obtain a FIM licence, the drivers/passengers must personally sign the "Acknowledgment and Agreement of the FIM Anti-Doping Code". All forms from under-age applicants must be counter-signed by their legal guardians.

The driver/passenger must return the entry form, duly completed, to his FMN, who must always approve the entry. Consequently, pages 1 and 2 of the entry form must bear the stamp of the FMN concerned.

Once the entry has been approved, the FMN concerned must forward the duly completed entry form to the FMNR/Organiser as soon as possible.

For each meeting of the 2013 FIM Sidecar Motocross World Championship, the closing date for entries is 30 days before the meeting in question.

The FIM can enter up to 5 sidecar teams before Thursday noon prior to the meeting.

The FIM must then inform the driver's/passenger's FMN, the FMNR and/or the organiser in writing, by fax or by e-mail before the end of the technical verifications prior to the meeting.

For these sidecar teams entered by the FIM, all listed entry conditions (apart from the closing date of entries) apply.

For each meeting, the number of entries is limited to the first 6 drivers of the final standings of the previous year's FIM Sidecar Motocross World Championship plus a maximum of 10 more drivers per FMN and 12 of the FMNR.

3. Starting numbers

Drivers who do not have a permanent starting number for 2013, according to the FIM information letter dated 22.11.2012 (<u>Sidecar permanent starting numbers</u>), may request a number for the current season.

This request must be made to the FIM Administration (sandra.berthoud@fim.ch) before the closing date of entries of the event in which the driver wishes to participate.

If the requested number is still available, it will be allocated to the driver.

Once a number has been issued to a rider - whether it was upon his request or by a decision of the FIM - it cannot be changed.
