GENERAL INFORMATION

Please note that:

1. The 2013 FIM SuperMoto World Championship entry form has been published on the FIM Website from where it must be downloaded:

208 - FIM SuperMoto World Championship - 2013 Entry Form

2. The 2013 FIM SuperMoto World World Championship entry form must be completed electronically in capital letters.

As a general rule, every rider wishing to participate in the 2013 FIM SuperMoto World Championship must enter through his FMN and YouthStream respectively.

The rider can enter for one, some or all of the meetings counting towards the 2013 FIM SuperMoto World Championship. Entry requests/provisional entries can be made by e-mail or telefax to YouthStream, but they must be confirmed with the duly completed official FIM entry form. We suggest that the rider puts a cross in the box of the respective meeting(s).

To be eligible for participation in FIM World Championships or Prize Events and in order to obtain a FIM licence, the riders must personally sign the "Acknowledgment and Agreement of the FIM Anti-Doping Code". All forms from under-age applicants must be counter-signed by their legal guardians.

The rider must then return his entry form, duly completed, to his FMN, who must always approve the entry. Consequently, pages 1 and 2 of the entry form must bear the stamp of the FMN concerned.

Once the entry has been approved, the FMN concerned must forward the duly completed entry form to YouthStream as soon as possible.

The closing date for entries for the first meeting of the 2013 FIM SuperMoto World Championship is 60 days before the meeting. As of the second meeting of the FIM SuperMoto World Championship, the closing date for entries is 30 days before each meeting.
