Slovakiaring is 5,992 km long. All races will be run clockwise. A drawing of the circuit is enclosed.

## 9/ Entries, Entry Fee:

All application for entry must be submitted via www.amboselli-racing.cz on the official form and must reach the organiser not later than 26.5.2013 (Closing date).

The entry fee is 1.000 CZK, but only rider, participating and having paid for two days riding, can take a part at ACCR Road Racing Cup.

The entry fee must be paid minimum two working days before the race. Rider can choose one or two days riding including of ACCR Road Racing Cup:

4.335 CZK + 1.000 CZK fee for one day participation 8.415 CZK + 1.000 CZK fee for two days participation

or in equivalent value in € according to the daily exchange rates.

Start is confirmed in advance on the base of completely and in time submitted entry. If number of riders allowed will be exceeded, the date of delivering will be decisive.

## 10/ Administrative checking and Technical inspection:

Administrative checking and Technical inspection will be held in paddock as follows:

Thursday **30.05.2013** 19.00 - 23.59 Friday 31.5.2013 19.00 - 22.00 Saturday **01.06.2013** 07.00 - 08.30

Foreigner riders must submitt at Administrative checking Starting permission issued by their FMN. In the case of crash, there will be next technical inspection.

#### 11/ Practice

Rider must finish minimum 5 laps in his class during the practices to be allowed to the race.

Practices will be held at Friday 31. 05. during Amboseli agency riding according to Time schedule published at <a href="https://www.amboseli-racing.cz">www.amboseli-racing.cz</a> or at Saturday 01.06.2013 as follows:

## 12/ Races and distances

19.30 Prize Giving will be held in paddock at AMBOSELI Racing place.

## 13/ Prizes:

Prizes will be awarded according to received points and three first riders in each class receive a cup. Points will be allocated to each rider as follows:

Place: 2 3 4 5 6 7 8 10 11 12 13 14 15 Points: 25 20 16 13 11 10 9 8 5 3 2

Additional scores: Pole position – 1 point Best lap in the race – 1 point

#### 14/ Prize Giving:

The Prize Giving Ceremony will be held after each race the AMBOSELI Racing Podium.

## 15/ Protests:

All protest must be made in accordance with ACCR Disciplinary Code and accompanied by fee 5.000 CZK / 170 EUR.

#### **16/ Fuel:**

Fuel must be in accordance to Road Racing Technical rules. A fuel station is in the circuit paddock.

#### 17/ Insurance:

In conformity with Art. 110.1 of the Sporting Code, organiser has third party insurance by ČPP in respect of riders covering accidents occurring during the event including practices.

Oganizer is obliged to arrange Thrid party liability insurance for riders. Fee for this insurance is a part of Entry fee.

Po By endorsing the application form for entry or issuing Starting permission the FMN of the rider certifies that the rider is insured in accordance to the FIM requirements.

Every rider must have a private accident insurance, which will declare by the administrative checks. The organiser disclaims all responsibility for damage to bike, its accessories and components.

#### **18/ LIMITATION OF LIABILITY**

By the submitting the entry the riders declare that they accept the requirement of regulations of these Supplementary regulations and they will strictly observe them. Modifications, additions and interpretations of these Supplementary Regulations are under exclusive competence of the management of the race, and the Jury.

#### Responsibility

Participants (incl., but not only: competitors, riders, mechanics, guests, etc.) take part in the event at their own risk. They carry sole civil and criminal legal responsibility for any damages or injury caused by them or the vehicle they are using.

## Renunciation of any Recourse against Sporting Authorities

Apart from the requirements of the ACCR Sporting Code, participants (incl., but not only: competitors, riders, mechanics, guests, etc by participating renounce all rights of appeal against the organiser, his representatives or agents by arbitration or before a tribunal or any other manner not foreseen by the ACCR Sporting Code for any damages for which they could be liable in consequence of all acts or omissions on the part of organiser, his officials, representatives or agents in the application of these regulations or contributed to or arising out of their actions.

#### 19/ Závěrečná ustanovení

Should circumstances or safety reasons demand it the event could be postponed or cancelled. For this the organiser cannot be held responsible. During the event can be made a tests of riders for presence of prohibited substances and alcohol.
