2. General

2.1 This competition will count towards:

3. The Description of the Circuit

Place: Autodrom Sosnová Length + Joker lap: 1198 m / 1400 m

Width of the start: 18 m Maximum Width: 14 m Minimum Width: 10 m

Composition: 10 % gravel a 90 % tarmac GPS location: 50.6581956N, 14.5402297E

4. Entry Forms - Entries

4.1 Anybody wishing to take part in the Competition must send the attached entry form duly completed to the Secretariat (address see above) until the 7th June 2019.

4.2 The maximum number of participants is for CEZ, MMČR, ČTHV - 100 vehicles and for Mascom Cup - 28 cars. For support race is maximum 72 cars.

5. The Entry Fees

5.1 The entry fee (insurance included) - 1st closing date of entries: **150** € for CEZ and MMČR, 2900 CZK for Mascom Cup, 2000 CZK for ČTHA – for every vehicle.

Entry fee has to be paid in closing date of entries latest.

Paddock fee is 6 + 6 € (services + power). The Confirmation of payment will be handled during administrative checking.

- **5.2** The participants applied after the first closing date of the entries will pay the fee 250 € (insurance included), Mascom Cup 5.500 CZK, ČTHV 3000 CZK.
- **5.3** A competitor may be charged an additional deposit of € 75 if he refuses to bear the sponsor's name.
- **5.4.** Entry fees may be refunded only:
- to candidates who are not accepted
- in the case of the Competition not taking place
- if the Competitor withdraws his entry no later 17. 6. 2019
- if the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, 50% only of the entry fee will be refunded.

6. Insurance

6.1 <u>Insurance coverage of the organiser</u>

The Autoklub CR concluded with "Kooperativa pojišťovna, a.s." – Vienna Insurance Group, through the company PLATINUM Consulting s.r.o., the frame insurance contract No. 7721116973 on insurance of liability of the organiser for damage caused to the others in connection with a sport enterprise up to the sum of CZK 10.000.000.

6.2 <u>Insurance of competitors and drivers</u>

The part of the frame insurance contract No. 7721116973 is insurance of cars of the participants against damages caused to third persons up to the sum of CZK 10.000.000 per one insurance event with co-participation of CZK 5.000. Any damage below CZK 5.000 will be paid by the driver who caused the damage; damages above CZK 5.000 will be paid by the insurance company without any co-participation of the insured. However the insurance does not cover liability for the damages caused by event participant that the competitors cause each other in the course of sport event.

6.3 Each driver is obliged to conclude his personal injury insurance and to present a proof on request the administrative checking. The insurance of foreign drivers must include coverage of costs for possible medical treatment in the CR.

IV. CHECKINGS

7. Administrative Checking

Every driver (or his / her representative) has to attend the administrative checking, taking place: on Friday, the 21st of June, 2019 from 15:00 – 21:00 o'clock in the marked area of the track.

8. Technical Scrutineering

8.1 Every vehicle has to attend the scrutineering, taking place on Friday, the 21st of June, 2019 from 15:00 – 21:00 o´clock in Headquarters.

8.2 For all cars, a limit of 100 dB is imposed.

V. RUNNING OF THE COMPETITION

9. Practice and the Information for drivers

- **9.1** The free practice session is 4 laps. Every driver must participate in at least one free practice session. Every driver must finish minimum one lap of the practice session. Otherwise his/her start in the first qualifying heat must be decided by the Stewards. The Joker lap can be used during the free practice session.
- **9.2.** The Kartcross division will run 2 official timed practices, the first one according the starting numbers while the second one in the reverse order.

10. Qualitying

There will be 4 laps in the qualifying. The Kartcross does not take the Joker lap. The car must be in the pre-start area five minutes before.

11. Semi-finals and Finals

- 11.1 Semi-finals will be 5 laps CEZ+MMČR+ČTHA+KC.
- **11.2** Finals will be 6 laps CEZ+MMČR+ČTHA+KC.

12. Flag signals

If the black flag or the black flag with the orange target is shown in a heat, the driver has to go immediately to the paddock. If the same situation happens in the final heat, the driver has to go to the Parc Ferme.

VI. PARC FERME - RESULTS - PROTEST

13. Protests - appeals

- **13.1** All protests are accepted and resolved in accordance with the paragraph 5.2 of the Disciplinary Code of the ACCR. All protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence any of the stewards, together with the sum of 11 500 CZK, in cash. The claimant must make a deposit of 250 000 CZK, If the protest requires any dismantling and re-assembly of different parts of a car.
- **13.2** Competitors have the right to appeal, as laid down in the paragraph 5.3 of the Disciplinary Code of the ACCR. The fee is 22 000 CZK.

13.3. Results

All results will be posted 10 minutes after every qualifying and final heat on the official notice board in the parking area.

13.4. Parc Ferme

The Parc Ferme is located in the central part of the circuit. There is no Parc Ferme for the ČTHA and Kartcross.

VII. PRIZES AND CUPS

14. Prizes

The podium ceremony - CEZ+MMČR+ČTHV+MC will be held on Sunday, the 23rd of June 2019 before Headquarters. The winners of the 1st, 2nd and 3rd prizes will follow an instruction of the marshals. Failure to attend this ceremony will be penalized by the loss of any monetary award / benefit associated with the corresponding position at the end of the race.

VIII. FURTHER INFORMATION

15. Fire extinguishers

Each driver is responsible to make sure there is a single piece of extinguisher of min. 5 kg available within his own team's area inside the paddock.

16. Protection of the environment

Each driver is obliged to keep a plastic sheet (minimum dimensions 4 x 5 meters) on the ground, under the vehicle, in the place where work on his/her car is done, in order to prevent any soil pollution in case of an accidental leak of oils or petrol, etc.

17. The Drivers' Liaison

The Drivers' Liaison Officer will be recognisable by orange vest, with his phone number and the sign Drivers' Liaison Officer written on it. His photo can be found on the official notice board. He can be reached Directorate of the Race.

18. Authorisation

These Regulations have been agreed by ACCR on 21st May 2019, Visa No. RX00219.

Appendix 1

- a) After the arrival to the Autodrom v Šosnová, every registered driver will be provided with 1+3 pieces of the identification bands with a digit code for later identification. Other bands if needed can be bought on the spot for 200 CZK (8 €) for a piece. All the participants of the race are required to wear the identification bands on the arm during the whole weekend. The bands must be shown when requested by the fee collector or by the organizer of the race. If a person is caught without the band, he/ she must buy one band or will be expelled out of the racing complex.
- b) Speed in whole area is limited to 30 km/h.
- c) Silent hours 24.00 p.m. 6.00 a.m.
- d) The parking space will be divided according to the instructions of the car park manager based on the application form.
