

## 4. FIA AND OTHER TITLES ELIGIBILITY

- 4.1. 2022 FIA titles towards which the event counts As per the FIA Sporting Regulations Article 15.
- 4.2. Other titles PHOENIX CONTACT Czech Trophy - ecoRally – National trophy organized in conformity with separate Supplementary Regulations (another document).

#### 5. VEHICLES ELIGIBLE TO PARTICIPATE

As per the FIA Technical Regulations Article 1.1

#### 6. GENERAL CONDITIONS

- 6.1. The event will be organised in conformity with:
  - the FIA International Sporting Code and its appendices;
  - the Sporting & Technical Regulations of the FIA E-Rally Regularity Cup;
  - the applicable prescriptions stated in the National Sporting Regulations; and
  - the present Supplementary Regulations.

The Organising Committee will ensure that the event complies with all the rules and regulations stated above, and that the event has received all the required administrative authorizations.

## 6.2. Insurance

The organiser has contracted insurance covering the following risks:

#### 6.2.1. Liability insurance of the event organiser

The liability insurance entitles the insured in case of insured event to have the insurer fulfilling claims of the harmed party related to property detriment (damage), or even another detriment to the extent and in the amount specified by law, insurance contracts and the respective insurance conditions, in case insured's obligation to pay reimbursement has arisen. The insurance covers the legally stipulated responsibility of the organiser for the detriment caused to health or property in relation to the organization of the event or in relation to training for it.

The insurance also covers damage cause by organiser on track event, its equipment and accessories or adjacent land, regardless of whether the property is owned or lease by the organiser or not.

The insurance under this paragraph shall not apply to damage caused to health or property of participant if this damage was caused by a participant (eg. driving mistake).

#### 6.2.2. Liability insurance of the event participant

The liability insurance entitles the insured in case of insured event to have the insurer fulfilling claims of the harmed party related to property detriment (damage), or even another detriment to the extent and in the amount specified by law, insurance contracts and the respective insurance conditions, in case insured's obligation to pay reimbursement has arisen. The insurance covers the statutory duty of the insured event participant to repay the harmed party (third party) detriment specified in DPPOP, in case insured's obligation to repay arose in connection with participation in the event or use of his/her vehicle.

As a third person is considered, among others, an official, officer and technical personal of the organiser at the event, including official officials of relevant international organizations, VIP guests and viewers. In case that this paragraph indicates a person in an employment relationship to the insured, he/she shall be considered as a third party in case he/she is delegated to the event or intended to perform certain functions during the event in accordance with international and national sporting regulations.

The insurance does not cover obligation of the insured to compensate the detriment caused to other participants of the event.

## 7. ITINERARY AND LAYOUT

Leg 1: Temelín – Český Krumlov (178,70 km) Section 1: 178,70 km – 3 regularity stages

#### Leg 2: Český Krumlov – České Budějovice – Český Krumlov (221.54 km)

<u>Section 2:</u> 138,32 km – 3 regularity stages <u>Section 3:</u> 83,22 km – 3 regularity stages

#### Leg 3: Český Krumlov – Olšina – Český Krumlov (187,74 km)

Section 4: 109,87 km – 3 regularity stages Section 5: 77,87 km – 3 regularity stages

Total distance of the rally: 587,98 km Total distance of the Regularity Stages: 342,10 km (58,18 %)

#### Generally:

Administrative checks, scrutineering and charging before the start are at the Temelín Nuclear Power Plant area. Centre of the rally is located at Český Krumlov, well known historical town in UNESCO. Parc fermé with overnight charging is located in the historical city centre.

Very demanding regularity stages in the South Bohemia region (currently or former stages of speed rally). The specialty of the tenth edition is the Thursday night leg.

End of rally is located under the castle in Český Krumlov before official finish of the 49<sup>th</sup> Rallye Český Krumlov (FIA European Rally Trophy).

Open air Prize-giving ceremony will be common for both rallies – many spectators, fans of motorsport, representatives of sponsors, unrepeatable night atmosphere.

All-inclusive catering for crews – coffee break and welcome buffet at the Temelín Nuclear Power Plant, Friday and Saturday lunch, Friday dinner in the centre of Český Krumlov.

Training stage (shakedown) with timekeeping will take place before a scrutineering near the Temelín Nuclear Power Plant. We recommend participation especially for newcomers.

#### Charging:

Before start, during whole event and after finish provided by the organiser. Participants are suggested to arrive to the Temelín Nuclear Power Plant on Thursday, May 19, 2022, no later than 10:00 to be able to fully charge their vehicles.

#### Parc fermé:

Overnight parc fermé will be situated in Parking P2 in the centre of the Český Krumlov. Participants may use charging infrastructure for charging their electric vehicles until Sunday, May 22, 2022, 10:00.

#### 8. RUNNING OF THE EVENT

#### 8.1. Nature of the event

The 10<sup>th</sup> ČEZ Czech New Energies Rallye is an E-Rally Regularity that has a combined final classification (regularity + energy performance index), as per the FIA Sporting Regulations, Article 3.

#### 8.2. Start, Finish, Results

8.2.1. The start signal for the event will be given at Temelín Nuclear Power Plant, Thursday, May 19, 2022. The first car will start at 19:00.

During the overnight stay and after the finish, the cars will remain in the Parc fermé, which they will enter as soon as they finish a Leg. Crews whose car is not in Parc fermé after the finish will be considered as retired.

The starting sequence will follow the participation number and the cars will start at one-minute intervals.

Early check-in to the TC 4A, TC 7A and TC 8A is permitted without penalty.

The detailed route is described in the Timetable (see Appendix 1).

## 8.2.2. Calibration zone

Calibration zone is located near the Temelín Nuclear Power Plant area. Roadbook for calibration zone will be published at the official notice board at Sunday, May 15, 2022.

#### 8.2.3. Administrative checks, scrutineering

Crew can enter administrative checks area after organizer instruction. Only one crew can be at the administrative check at the time (due to COVID-19). If a crew uses after scrutineering the calibration zone or takes part in the Regularity training camp, they must return the vehicle to the Parc fermé no later than 17:00.

#### 8.3. Regularity stage starting procedure, Official time

- 8.3.1. Crews start into regularity stages in the order they arrive at START position, marked with a clearly visible panel with a black flag in a red field. The start procedure will be unmanned without a timekeeper and clock. The crew may start to the stage at any time at their own discretion, however it must always be a full minute by the official competition time!
- 8.3.2. The official time is astronomical time available online at <u>www.time.is</u>.
- 8.3.3. If the crew will arrive to the Start Control Area, marked with panel in A3 format with a black flag in a yellow field, it must leave this area until 60 second. Failure to comply with this limit will be punished 500 penalty points.

#### 8.4. Roadbook

Detailed roadbook for each leg will be provided 15 minutes before each crew start time. Roadbook will be distributed by the Competitor Relations Officer at the Parc fermé entrance – TC 1, TC 3 and TC 6.

## 8.5. Timing equipment and Tracking system

All cars must be equipped from the scrutineering until finish of the rally with two data processing units. These units are used for results processing, for tracking any road book deviations and for tracking any breach of the traffic rules (e. g. speeding). Competition car not equipped with GPS monitoring devices will not be allowed to start.

Deposit for GPS timekeeping and tracking system: 2 000 CZK (80 EUR)

## 8.6. Highway code

- 8.6.1. Throughout the duration of the rally, the crews must strictly follow the traffic laws of the countries crossed. Any crew not complying with these traffic laws will be penalized as follows:
  - 1st infringement = 1 800 points
  - 2nd infringement = 3 600 points
  - 3rd infringement = exclusion from rally
- 8.6.2. Exceeding maximum allowed speed authorised by the highway code with 10 % tolerance will result: 1st infringement = 10 points + 5 EUR per km/h over the speed limit (+10 %) example: speed 56 km/h in a village = 10 penalty points and 5 EUR fine 2nd infringement = 50 points + 15 EUR per km/h over the speed limit (+10 %) and infringement = ovelueion from rolly.
  - 3rd infringement = exclusion from rally
- 8.6.3. Speeding will be checked with GPS units installed in the car.

- Type of sockets: Type 2 (Mennekes) max. 30 cars

  - o Thursday, 19. 5. 2022 Friday, 20. 5. 2022: 10 hours 50 minutes
  - o Friday, 20. 5. 2022 Saturday, 21. 5. 2022: 17 hours

## 10. PERFORMANCE INDEX CALCULATION

As per the FIA Sporting Regulations, Article 3

#### 11. ENTRY PROCEDURE AND FEES

The amount of the entry fee is fixed for each crew comprising two people (driver and co-driver, or driver and navigator):

- a) With the optional advertising proposed by the Organiser: 500 EUR (incl. 21 % VAT)
- b) Without the optional advertising proposed by the Organiser: 1 000 EUR (incl. 21 % VAT)

## <sup>11.1</sup> Entry Fee Refund

- Entry fees will be refunded in full:
- If the entry is not accepted.
- If the event is cancelled.
- The Organiser will refund 50 % of the entry fee to them who excused seven (7) days before start of administrative check.

#### <sup>11.2</sup> Crew documents

A crew comprises one driver and one co-driver, or one driver and one navigator.

Both must be a holder of the following documents:

- ✓ Driving licence according to the entered vehicles (not applicable for the navigators only)
- ✓ Any grade of FIA licence, issued by their ASN, or
- ✓ An FIA licence, grade D (or equivalent), obtained for the event, and valid for its duration, which has been issued by their ASN or by the organiser's ASN (with the written permission of the competitor's ASN) and handed over to the participants at the latest during the administrative checks. It will be subject to the payment of a fee of 200 CZK (8,50 EUR).
- ✓ Vehicle document permitting its free circulation on public roads.
- ✓ Should it be applicable, a vehicle document required in the Technical Regulations of the FIA ecoRally Cup.
- ✓ Vehicle valid insurance certificate in accordance with the vehicle laws.

#### 11.3. Entry Form

Any person, or legal entity, wishing to participate to the event must submit a properly filled-in entry form on www.cner.cz before Sunday, 8. 5. 2022, 22:00.

By submitting the entry form, both crew members confirm that they have valid personal accident insurance for the duration of the competition.

11.4. The field for participation is limited to a total of 30 entries.

All entry forms received after the above number of vehicles has been accepted will be entered to the PHOENIX CONTACT Czech Trophy - ecoRally.

11.5. The minimum number of entries is as per the FIA Sporting Regulations, Article 12.

## 13. PROTESTS / APPEALS

The amount of the protest fee is 800 EUR.

Protests against the preliminary official results of the event must be lodged, in writing, in accordance with the prescriptions set in the ISC with the Clerk of the Course within 30 minutes of the moment of their posting on the official notice board. Upon the expiration of this time period, the preliminary results become final.

Every protest is eligible to be examined by the Stewards of the event only if it is accompanied by the aforementioned protest fee defined in this article, which is not refundable should the protest fail to be upheld.

For the National Court of Appeal, the fees are 1 560 EUR.

For the FIA International Court of Appeal, the fees are 3 000 EUR.

## 14. APPLICATION AND INTERPRETATION OF THE REGULATIONS

In case of a dispute over the interpretation of the regulations, the English text will prevail.
