3. <u>Entry forms - Entries</u>

3.1 Anybody wishing to take part in the Competition has to send the attached entry form duly completed to the Secretariat at below mentioned address **till 25th of July 2022 12pm** (normal entry fee).

4.1 The Entry Fees

a) The entry fee is 200 € for every vehicle (without insurance), except the drivers of the Mascom Cup (paying 4500 CZK/vehicle without insurance) and the drivers of the Czech Trophy of the historic cars (paying 3000 CZK/vehicle without insurance).

b) The participants applied after the first closing date of the entries is obligated to pay the fee 400 € (insuranace included), Kartcross 6480 CZK and ČTHA 4 980 CZK.

4.2 The organizer is responsible for issuing an invoice.

The entry fee will be collected during the administrative checking. None vehicle will be allowed for the competition unless the entry fee is fully paid.

The entry fee can be paid in the Czech currency at the exchange rate valid for the 5th of August 2022.

4.3 Entry fees may be refunded only in below mentioned cases:

a) to candidates who are not accepted for the Competition

b) in case the Competition will not take place

c) the withdrawal is announced to the organizer not later than Monday 25th of July. If the withdrawal is announced after this date but till the opening of the administrative checking only 50% of the entry fee will be refunded.

5. The insurance

5.1 <u>The insurance of the organizer</u>

The ACCR has concluded the framework insurance contract No. C550012623 on insurance of liability of the organizer for damage caused to the others in connection with a sport enterprise up to the sum of 11.000.000 CZK with the "Allianz pojišťovna a.s." via the PLATINUM Consulting s.r.o. company.

5.2 The insurance of the competitors and drivers

The framework insurance contract includes insurance for the liability of the participants caused to third persons by the participant or by vehicle operation. However, the insurance does not cover liability for the damages caused to the other participants of the event. The indemnity limit per participant is of the sum of 11 000 000 CZK per one insured event, with an integral franchise of 5 000 CZK, meaning the damages below CZK 5 000 will be not refunded, the damages above the limit of 5 000 CZK will be fully paid.

5.3 Each driver is obligated to arrange his own personal accident insurance which must be shown at the administrative checking (for the FAS ACR licence holders, the license itself is sufficient). The insurance of the foreign drivers must include coverage of costs for possible medical treatment in the Czech Republic.

6. Administrative checking

Every driver (or his / her representative) has to attend the administrative checking taking place on Friday the 5th of August 2022 from 16.00 till 20.30 o'clock (the hall at the control tower). Or Saturday 6th of August 2022 from 07.30 till 08.30

7. Scrutineering

7.1 Every vehical has to attend the scrutineering taking place on Friday the 5th of August 2022 from 16.00 till 20.30 o'clock (by the control tower). Or Saturday 6th of August 2021 from 07.30 till 08.30

7.2 For all cars, a limit of 100 dB is imposed.

8. Practice and Information for drivers

8.1 <u>Practice and The Drivers' Briefing</u>

One free practice session should last at least 90 minutes. The free practice session is 4 laps. Every driver must participate in at least one free practice session. Each division will start individually. Every driver must finish minimum one lap of the practice session. Otherwise his/her start in the first qualifying heat must be decided by the Stewards. The Joker lap can be used during the free practice session.

The Kartcross division will run 2 official measured practice sessions, the first one according the starting numbers while the second one in the reverse order. The practice session is 4 laps starting with the first crossing of the finish line and all laps count.

The briefing notes for the competition in writing will be given to all drivers at the administrative checking.

9. Qualifying

There will be **4** laps in the qualifying heats. The Kartcross division does not take the Joker lap.

10. Semi-finals and Finals

There will be **6** laps in the semi-final and final heats. The Kartcross divison does not take the Joker lap.

11. Flag signalisation

In case a black flag or a black flag with an orange target is presented during the race, the driver must immediately go to the paddock or, during the finals, to the Parc Ferme.

12. Protests - appeals

12.1 All protests are accepted and resolved in accordance with the paragraph 5.2 of the Disciplinary Code of the AS AČR. All protests must be made in writing form and handed to the Clerk of the Course or his assistant, or in their absence any of the stewards, together with the sum of 11 500 CZK, in cash. The claimant must make a deposit of 250 000 CZK, if the protest requires any dismantling and re-assembly of different parts of a car.

12.2 Competitors have the right to appeal, as laid down in the paragraph 5.3 of the Disciplinary Code of the AS AČR. The fee is 22 000 CZK.

13. Prizes and Cups

The prize giving ceremony will be held on Sunday, the 7th of August 2022, in the area of the control tower, 30 minutes after the finals. The winners of the 1st, 2nd and 3rd prizes must be present, wearing their racing suits.

14. Driver 's Liaison Officer

The Driver's Liaison Officer can be identified by an orange vest with his phone number and the sign *Driver's Liaison Officer* written on it. His photo can be found on the official notice board. He can be reached in the secretariat, in the starting area or near to the Parc Ferme after the finals.

15. Further information

The briefing notes for the competition in writing form will be given to all drivers electronically along with the confirmation of the start to the driver's email.

The Parc Ferme is located in the central part of the circuit. There is no Parc Ferme for the ČTHV and Kartcross divisions.

16. Authorisation

Others

After the arrival to the AK RAC Sedlčany circuit, every registered driver will be provided with 1+3 pieces of the identification bands with a digit code for later identification.

Other bands if needed can be bought on the spot for 200 CZK for a piece. All the participants of the race are required to wear the identification bands on the arm during the whole weekend. The bands must be shown when requested by the fee collector or by the organizer of the race. If the person is caught without the band, he/ she must buy one band or will be expelled out of the racing complex.
